Sub: - Offer of appointment to the post of Clerk.

On the recommendations of the Secretary, Haryana Staff Selection Commission, Panchkula received vide his office Memo No.HSSC/Confid./Recomm/2020/433 dated 07.09.2020, you are hereby offered an appointment as Clerk in the Pay Matrix FPL-2 plus usual allowances as admissible. You will be granted the allowances as admissible to the employees of the Housing Board Haryana under rules/instructions governing the grant of such allowances enforced from time to time.

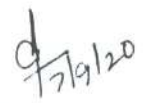
2 Your offer of appointment is subject to the following conditions:-

- As your character and antecedents have not been verified by the Commission as informed vide Memo No.52/18/2018-3GSIII dated 18.08.2020, therefore, it is made clear to you that in case subsequently any adverse facts come to the notice of the Housing Board regarding your character and antecedents, your services are liable to be terminated.

- (ii) Your appointment shall be subject to the verification of documents pertaining to your qualification, age, caste/category and Universities as claimed by you in the application form furnished with the Haryana Staff Selection Commission.
 - (iii) You will be required to qualify probation period of two years from the date of your joining which can be extended upto another one year and you will be retained in service only if your work and conduct during the probation period is found to be satisfactory, failing which your service will be terminated by the competent authority without any prior notice.
 - (iv) Your services will be governed under the provision of Bye-Laws of the Housing Board Haryana framed or to be framed hereinafter from time to time and the Haryana Civil Services Rules/instructions applicable to the Haryana Govt. Employees from time to time will also be applicable upon you, as the case may be, while there is no conflict in the rules. In case of conflict, the Bye-Laws of the Board shall be enforced.
 - (v) You shall be liable to serve in any part of Haryana State.
 - (vi) You shall submit Medical Certificate duly issued by CMO/Civil Surgeon, Panchkula within 15 days of joining. Your joining would be subject to your submission of medical fitness.
3. Your appointment will be on a purely temporary basis against a temporary vacancy terminable on one month's notice without assigning any reason on either side except in case of removal for misconduct etc. and in case, your academic qualification/caste/ category certificate is found bogus. Your services shall be terminated without any notice and a criminal case will be got registered against you. It will, however, be open to the Housing Board to pay emoluments in lieu of notice or for the period by which the said notice falls short for a month. Similarly, if you wish to resign or quit your post, you may do so by depositing emoluments equal to one month with the Housing Board in lieu of the notice or for the period by which the said notice falls short of a month.
4. It is made clear that you will not undertake higher studies of any kind without obtaining prior permission. Consequently, no leave of any kind will be granted for pursuing higher studies.
5. You will be governed under New Pension Scheme (NPS).
6. No TA/DA will be granted to you for joining the appointment.
7. This offer of appointment is further subject to the following conditions:-
- (i) You will submit your academic Educational / professional certificate/caste certificate in original for verification along with photocopies duly attested by the Gazetted Officer for record.
 - (ii) If married, you will submit a certificate that you have not more than one living spouse. In case, it shall be noticed that you have more than one living spouse, your services will be terminated without giving any notice.
 - (iii) You have not been convicted by any Court of the Country.

- (iv) You will submit a declaration after marriage that you have not taken any dowry. Your wife, father and father-in-law shall sign this declaration.
8. You will have to qualify the State Eligibility Test in Computer Appreciation and Application (SETC) within one year failing which no increment will be granted till the said test is qualified.

If this offer of appointment is acceptable to you on the conditions mentioned above, you should report for duty at Housing Board Haryana, Head Office Panchkula within 15 days positively from the issue of this letter failing which it will be presumed that you are not interested to join and your name will be removed from the list of selected candidates and this offer shall stand withdrawn.

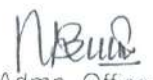
