You have joined in the Housing Board Haryana on 21.08.2014 as Junior Engineer (Electrical). You have acquired Degree of Electrical Engineer in the year 2013 as well as degree in Civil Engineer in the year 2023. On your request your case for promotion was considered.

Your promotion as Assistant Engineer (Civil) is against the Civil Service Rules and latest Housing Board Rules published vide gazette notification no. 0/14/2013-2HG dated 24.04.2018. It is clearly mentioned in the rules of Housing Board regarding the promotion from Junior Engineer (Civil) to Assistant Engineer (Civil) in **Appendix B at Serial No. 23.**

Your order of promotion from Junior Engineer (Electrical) to Assistant Engineer (Civil) has reduced one post of AE (Civil) from promotion quota will effect the seniority of Junior Engineers (Civil) and in this regard representation has also been submitted by Junior Engineer (Civil).

You are having the charge of Assistant Engineer (Electrical) and passed the degree in Civil Engineer in the year 2023. Hence, your name in the seniority list of Junior Engineers (Civil) was only to be considered after the Junior Engineer (Civil) appointed in the year 2020 having Degree in Civil Engineering. For this purpose relaxation is also required from the Government for promotion to the post of Assistant Engineer (Civil) as per Rule-19 of HBH Service Rules. Hence your reversion from the post of Assistant Engineer (Civil) to Junior Engineer (Electrical) is hereby proposed.

However, an opportunity to make a submission, if any, which you may like to make in his connection, will be considered by the competent authority before proceeding further in the matter. Such representation, if any, should be made in writing and submitted to the undersigned so as to reach not later than 7 days from the date of receipt of this notice. It is further clarified that no extension of time shall be granted to you to submit your representation, failing which it will be presumed that you have nothing to say in this regard and ex-parte decision will be taken.
