Subject:- Revised e-auction policy.

1. In continuation to this office letter no. CCF-HSVP-AO-I-2020/85235-36 dated 16.06.2020, on the subject cited above.
2. The revised e-auction policy issued vide letter under reference was placed in 120th meeting of the Pradhikaran held on 29.09.2020 for ex-post-facto approval. The Pradhikaran approved the same with the observation that:-

"Three Committees have already been constituted for taking decision on bids below reserve price. The e-auction results may be provided to the Committee on the date of auction itself and the meetings of the Committee held may be scheduled as following:-

- (a) First Committee within three days of date of auction
- (b) Second Committee within seven days of the date of auction.
- (c) Third Committee within ten days of the date of auction".

3. Keeping in view the above decision of the Pradhikaran and approval obtained on file following Committees are constituted for analysing and acceptance of bids below the reserve price:

Where the highest bid is below 5% of the reserve price	. Principal Secretary, Town & Country Planning . Chief Administrator, HSVP	Within three days from date of auction
Where the highest bid is in the range of 5%-20% below the reserve price	. Additional Chief Secretary (Finance) . Principal Secretary, Town & Country Planning . Principal Secretary to Chief Minister . Chief Administrator, HSVP	Within seven days from date of auction
Where the highest bid is more than 20% below the reserve price	Sub-Committee of Council of Ministers	Within ten days from date of auction
