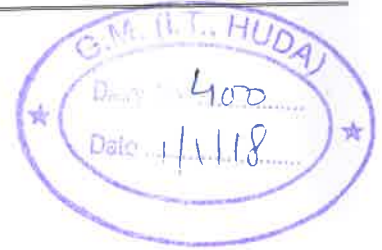

It is to inform you that on the basis of enhanced compensation awarded by the Hon'ble High Court vide order dated 22.07.15 in No. 5585/14 pertaining to the acquired land for the development of Sector-11, Fatehabad, the recovery rate of additional price (2nd EC) has been worked out @ **Rs. 5209.00 Per Sq. Mtr. for General Category and @ Rs. 302.00 Per Sq. Mtr. for EWS Category**.
