Subject: Online provision for registration/empanelment of Supervisors on HSVP OBPAS Portal.

With reference to the subject cited above, it is informed that Haryana Shehri Vikas Pradhikaran (HSVP) has developed system-driven online facility for registration and annual renewal of Supervisors has now been developed and made functional on the OBPAS portal (<https://obpas.hsvphry.org.in>) with the approval accorded by the Competent Authority

Under the developed system, eligible Supervisors shall be required to apply for registration and annual renewal exclusively through the OBPAS portal, by furnishing the requisite details and uploading the prescribed documents, strictly in accordance with the qualification and competency provisions notified under the Haryana Building Code-2017, as amended vide Memo No. Misc-2339-(ULB)-VOL-II/7/5/2006-2TCP dated 27.05.2020. Further, the existing manual process for registration and renewal of Supervisors shall stand replaced by the online mechanism.

Upon successful online submission, the application shall be digitally routed to the concerned Zonal Administrator through the system for scrutiny and decision. The Zonal Administrator shall be the competent authority for approval or rejection of such applications. The entire process shall be carried out online, ensuring transparency, uniform application of eligibility criteria and digital record-keeping. Automated SMS intimation shall be generated by the system to the applicant upon acceptance or rejection of the application.

To ensure uniformity in the empanelment and renewal process, it is further clarified that the empanelment of all Supervisors shall be valid only up to 31st December of the relevant calendar year, irrespective of the original date of registration or renewal, and shall be required to be renewed annually as per the prescribed norms.

Empanelled Supervisors shall be permitted to prepare, sign and submit building plans and supervise construction of building as permitted under Haryana Building Code.


